

## TERMS AND CONDITIONS OF RUN FOR A REASON CONTEST

### 1. The Organiser

1.1 The **Standard Chartered Marathon Singapore (SCMS) Run for a Reason** (the "Contest") is organised by the Singapore Sports Council ("SSC") of 230 Stadium Boulevard, Singapore 397799, in conjunction with the Standard Chartered Marathon Singapore ("SCMS"), with Standard Chartered Bank as the title sponsor.

### 2. Eligibility

2.1 The Contest is open to all Singapore citizens, Permanent Residents, and any individuals (except for SSC's employees involved in the organisation of the Contest) residing in or possessing a permanent residential address in Singapore, as well as overseas participants of the SCMS 2011.

2.2 All individuals under the age of 18 should seek parents' or guardians' approval and consultation before taking part in the Contest.

### 3. Duration of Contest

3.1 The duration of the Contest ("Contest Period") for the Standard Chartered KL Marathon 2012 shall be from **10:00, 1 December 2011** ("Start Date") to **21:00, 3 December 2011** ("End Date"), Singapore time (GMT +0800).

3.2 The duration of the Contest ("Contest Period") for the Beijing and Gold Coast Airport Marathon 2012 shall be from **12:00, 28 November 2011** ("Start Date") to **23:59, 19 December 2011** ("End Date"), Singapore time (GMT +0800).

### 4. How to Participate

4.1 Anyone who wishes to take part in the Contest (the "Participant") to win the 10 running slots for the Standard Chartered KL Marathon 2012 must visit the Run for a Reason booth at the Race Entry Pack Collection from 1 to 3 December 2011. The Participant must pen down his/her reasons for taking part in the SCMS 2011 and drop them into a box at the booth. Ten reasons will be selected and the winners will each be rewarded with a race registration slot for the Standard Chartered KL Marathon 2012.

4.2 Anyone who wishes to take part in the Contest (the "Participant") to win the pair of running slots inclusive of two nights of accommodation and airfare to Beijing Marathon 2012 must submit an inspirational photo that depicts his/her reasons for taking part in the SCMS 2011, along with supporting reasons of no more than 300 words, via email to [contest@marathonsingapore.com](mailto:contest@marathonsingapore.com) during the Contest Period.

4.3 Anyone who wishes to take part in the Contest (the "Participant") to win the pair of running slots inclusive of two nights of accommodation and airfare to Gold Coast Airport Marathon 2012 must submit an inspirational video that depicts his/her reasons for taking part in the SCMS 2011, along with supporting reasons of no more than 300 words, via email to [contest@marathonsingapore.com](mailto:contest@marathonsingapore.com) during the Contest Period.

4.4 The Entry must be received by SSC no later than the End Date. For the avoidance of doubt, the Entry will be deemed received by SSC when accepted by SSC's email server.

4.5 There is no limit to the number of Entries the Participant may submit for the Contest.

## 5. Entry Requirements/Criteria

- 5.1 The Entry should include the Participant's full name, NRIC, contact number and email address.
- 5.2 The Entry must be original and must not be copied from another established name or tagline in use. SSC reserves the right to cancel the award and forfeit the prize if it is subsequently found out that the name is identical or very similar to another name of an entity or product or service.
- 5.3 Each Entry will be vetted by SSC to ensure that the Entry meets all requirements stipulated in these terms and conditions before the Entry shall be deemed eligible for the Contest.

## 6. Conduct of Contest and Winning Entries

- 6.1 The winning Entries will be selected by SSC in a manner deemed fit and appropriate by SSC.
- 6.2 SSC have the sole right to decide all matters and disputes arising from the Contest and that all decisions of the judges are final and binding.
- 6.3 The winning Entries will be selected by a panel determined by SSC based on the following criteria :

- 6.4 SSC reserves the right to substitute any winner subsequently found to be disqualified. SSC also reserves the right, at its sole and absolute discretion, to determine if there will be no winner at all. SSC's decision is final and no correspondence will be entertained.
- 6.5 SSC reserves the right to use, assign or dispose entries without approval of or compensation to the Participants or any third parties.

## 7. Winner Notification and Collection of Prizes

- 7.1 The winning Entries and the name(s) of the winning Participant(s) will be announced and published on the Contest Website, within fourteen (14) working days after the winning Entries has been selected. SSC may additionally request that the prize winner(s) turn up for a photo shoot.
- 7.2 SSC will notify the winner(s) by email, telephone or post (to be decided at SSC's discretion) within seven (7) working days after the winning Entries have been selected (the "Notification"). SSC shall not be liable for late, lost, misdirected or unsuccessful efforts to contact and notify the prize winner.
- 7.3 All prizes must be collected in person at SSC HQ (230 Stadium Boulevard, Singapore 397799) within thirty (30) working days from the date of Notification.
- 7.4 Prizes not claimed within thirty (30) working days from the date of Notification may be forfeited, withdrawn or given to a reserve winner at the sole and absolute discretion of SSC in accordance with the relevant local laws and regulations.
- 7.5 Proof of identity must also be provided at the point of collection. No right to compensation shall accrue nor be given to the winner(s) if he/she fails to provide proof of identity as well

as his/her relevant Personal Details accurately to SSC at the point of collection or fails to claim the prize in accordance with the collection instructions provided in the Notification.

## 8. Prizes

8.1 There will be a total of twelve (12) winners in this contest.

8.2 All prizes are non-transferable, non-refundable and non-exchangeable for credit, and are subject to any terms and conditions as may be imposed by the merchant, service provider or supplier of the prizes. SSC shall not be liable for any variation in the prizes or prize values, notwithstanding anything in these terms and conditions and without prejudice to this clause. SSC reserves the right at any time and at its sole and absolute discretion, to substitute, withdraw or cancel any prize or make changes to the value and/or number of the prizes at any time without prior notice and without having to disclose any reason therefor and without any payment or compensation whatsoever in lieu thereof.

8.3 All ancillary costs and expenses, duties, value added taxes or tax liability incurred by the winner as a result of winning or otherwise in connection with the prize, shall be the sole responsibility of the winner. SSC shall not be liable for any taxes (including but not limited to income tax), costs, expenses or duties that may arise from the winning of or otherwise in connection with the prize. Please also take note of the local laws and regulations which may govern the issuance or receipt of or otherwise in connection with the prize. Without prejudice to this clause, to the fullest extent permitted by law, SSC excludes all liability for any loss or damage whatsoever suffered (including, without limitation, indirect or consequential loss), or for personal injury suffered or sustained in connection with the Contest or as a result of issuance, receipt and use of, or otherwise in connection with any of the prizes.

## 9. Participant's Warranties and Undertakings

9.1 By participating in the Contest, you represent, warrant, undertake, agree and/or acknowledge that:

- a) the information, details and particulars submitted by you to SSC are true, accurate and complete. Any incomplete Entry (including failure to furnish all the required details) may be disqualified from the Contest at SSC's sole and absolute discretion;
- b) you are the sole legal and beneficial owner of all intellectual property rights to your Entry and your Entry does not infringe on any copyright or other proprietary right of any third party, and you agree to indemnify and hold SSC harmless from and against any and all claims, losses, damages, liability and costs resulting therefrom;
- c) you grant to SSC (upon your participation in the Contest) an irrevocable, royalty-free licence to use the copyright and all other intellectual property rights of whatever nature in your Entry for publicity and communications purposes related to the Contest and/or SSC generally on websites, during presentation, on or in any printed or video materials, or in any other mode(s);
- d) you will not submit an Entry that defames, abuses, harasses, stalks, threatens or otherwise violates the legal rights (such as rights of privacy) of others;
- e) each Entry that you submit should be made strictly in accordance with these terms and conditions – otherwise, such Entry may be disqualified, at the sole and absolute discretion of SSC; and
- f) you have read and understood, and thereby agree to all the terms and conditions of participation in the Contest as set out herein, including all amendments, additions, replacements and modifications ("**Amendments**") hereto as may from time to time be

made by SSC. SSC shall notify participants and the public of such Amendments by a notification to be posted on the Contest Website.

## 10. Miscellaneous

### Personal Details

- 10.1 SSC collects your Personal Details in order to conduct the Contest, and may pass that information to its related bodies, corporations and agencies assisting with the Contest.
- 10.2 By participating in the Contest, you consent to the public disclosure of your Personal Details including your name, photo, biography and other identification details, etc., for the publicity purposes of SSC in relation to the Contest or otherwise, and without payment or compensation therefor.

### Contest Fitness and Variation

- 10.3 The Contest Period may be extended or shortened at SSC's sole and absolute discretion.
- 10.4 SSC reserves the right to disqualify – at its sole and absolute discretion, any Entry which it deems inappropriate and to not post such Entry on the Contest Website and/or YouTube and/or related servers. In the event of the aforesaid disqualification, no explanation will be provided by SSC.
- 10.5 Without prejudice to other clauses hereto enabling SSC to disqualify any Entry, SSC reserves the right to declare any Entry void and to modify the Contest or any part thereof or to cancel the entire Contest at any time during the Contest Period should SSC decide at its sole and absolute discretion that no Entries meet SSC's required or desired standard.
- 10.6 Notwithstanding anything in these terms and conditions, SSC reserves the right at any time and at its sole and absolute discretion to determine and/or amend, by addition to, deletion from or variation of, these terms and conditions without prior notification, including but not limited to the terms and conditions concerning the eligibility for the Contest, criteria for the Contest and the selection of winners.

### Liability and Indemnity

- 10.7 SSC makes no warranties or representations whatsoever and whether express or implied, in respect of the Contest Website or any of its contents (including but not limited to the merchantability or fitness for a particular purpose of the prizes or in relation to whether the content and delivery of the Contest Website is free from errors, bugs or viruses, uninterrupted or repairable if damaged or impaired).
- 10.8 SSC shall not be liable for any incomplete, lost, late, damaged, illegible or misdirected Entries for any reason whatsoever or problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the internet or at any website, or any combination thereof, (including but not limited to) any injury or damage to your or any other person's computer related to or resulting from participation in the Contest.
- 10.9 You (including your heirs, executor and/or administrators) hereby agree to indemnify fully and hold SSC and its directors, officers, employees, and assignees or any other associated sponsors thereof (the "**Indemnified Parties**") harmless from and against any and all claims, losses, liability or damages (including but not limited to economic loss, damage to any property or injury to or death of any person and any legal costs) that may be suffered or incurred by any of the Indemnified Parties arising whether directly or indirectly from:
  - (a) any negligent act or omission or willful default, misconduct or fraud by you; or
  - (b) any action, claim, loss, damage, cost and expense whatsoever brought against, suffered or incurred arising from or in connection with any breach of the terms and

conditions hereunder (including, without limitation to the generality of the foregoing, a breach of the representations, warranties, undertakings, agreements or acknowledgements) by you.

10.10 Neither SSC nor SSC's employees, affiliates, representative offices, authorised agencies or any other associated sponsors associated with the Contest shall be held liable for any failure or omission to carry out the Contest in accordance with these terms and conditions or for any loss or damage suffered by you in relation to the Contest or your participation therein, including where such failure, omission, loss or damage arises out of or in connection with any event of force majeure, including without limitation any calamity or conditions, Acts of God, war or warlike hostilities, civil commotion, riots, blockades, embargoes, sabotages, strikes, fires, lockouts, shortages of material or labor, terrorist activity, epidemic, quarantine restrictions, health risk or any defect, failure, or any other occurrence beyond the reasonable control of SSC, SSC's employees, affiliates, representative offices, authorised agencies or any sponsor associated with the Contest, as the case may be.

#### Others

10.11 Information on how to enter the Contest and on the prizes found on the Contest Website shall form part of these terms and conditions governing the Contest.

10.12 SSC's decisions in all matters related to the Contest, prizes and prize winner shall be final and binding. No discussions, correspondence or appeals shall be entertained in relation thereto.

10.13 In the event of any inconsistency between these terms and conditions and any brochures, marketing or other promotional materials or communications relating to the Contest, these terms and conditions shall prevail.

10.14 The Contest and these terms and conditions shall be governed by and construed in accordance with the laws of Singapore, and by participating in the Contest, you submit to the exclusive jurisdiction of the Courts of the Republic of Singapore.
